I HAVE JUST SPENT TWO HOURS WITH ROA. I WENT OVER POINTS MADE IN EMBTEL 133 AS MODIFIED IN DEPTEL 74 IN CONSIDERABLE DETAIL WITH ELABORATIONS BASED ON RECENT DEVELOPMENTS HERE. ROA WAS CORDIAL, GAVE ME FRIENDLY PERSONAL MESSAGE FROM CASTRO WITH WHOM HE HAD JUST BEEN AND AGREED ARRANGE MEETING FOR ME WITH CASTRO NEXT WEEK.

ROA EXPRESSED STRONGLY ANTI-COMMUNIST VIEWS RECALLING THAT VIOLENT ATTACKS ON HIM BY CUBAN COMMUNISTS HAD SAVED HIM WHEN BATISTA HAD ATTEMPTED ARREST HIM AS COMMUNIST. HE BELIEVES COMMUNIST INFLUENCE IN GOVERNMENT NON-EXISTENT AND THAT AIMS AND IDEALS OF GOVERNMENT CONTRARY COMMUNIST IDEOLOGY.

WITH REGARD RECENT EXPEDITIONS AGAINST DOMINICAN REPUBLIC, HE STATED FLATLY HIS CONVICTION THESE DID NOT ORIGINATE IN CUBA.

ARISING FROM CAMPESINO CONCENTRATION AND PERSISTENT ANTIAMERICANISM HERE. HE AGREED HE WOULD SPEAK TO PRESIDENT ABOUT
THIS AND TAKE DISCREET PRECAUTIONS TO WATCH EMBASSY. I POINTED
BUT THAT ACTING MINISTER HART HAD TOLD ME SOME WEEKS AGO THAT
