

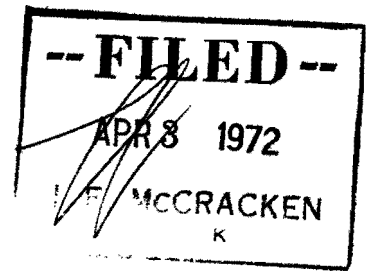

COMES NOW, RICHARD E. GERSTEIN, State Attorney of the Eleventh Judicial Circuit of Florida, by and through the undersigned Assistant State Attorney, and moves to strike the Demand for Speedy Trial filed by the defendant on January 17, 1973.

As grounds for this Motion, the State of Florida alleges:

1. The defendant is unavailable for trial as required by Rule 3.191 Fla. RCrP.
2. The defendant is presently incarcerated at the Federal Detention Headquarters in New York City, New York.
3. The defendant also is designated for the U. S. Penitentiary in Atlanta, and accordingly is not available for trial in Florida at this time.
4. The State Attorney's Office of the Eleventh Judicial Circuit of Florida is therefore unable to obtain jurisdiction over this defendant.

WHEREFORE, RICHARD E. GERSTEIN, State Attorney of the Eleventh Judicial Circuit of Florida Prays that the Defendant's Motion for Speedy Trial be stricken.


