We published yesterday full accounts from Nicaragua of yesterday's Herald. To day we are enabled to give additional details of considerable interest from that quarter.

We have received your full account, and so will the operations of the San Juan de Nicaragua of the morning at headquarters, which have been furnished to us by gentlemen who came down from San Juan del Sur to the Orizaba. That ship went to San Juan del Sur, as usual, with her passengers from San Francisco, no news of the interruption of the Transit route was there with a detachment of 200 or 300 men to receive the recruits from San Francisco, who numbered only thirty. Finding that the Transit route was in the hands of the Costa Ricans, the Orizaba went to Panama, whence the passengers for San Francisco were taken by the Panama steamer, and returned by railroad to Apizaco.
