How the reporter could have secured information as to Departments instructions, in this matter, I am at a loss to know, as Mr Baralson only gave the information to the Collector, Capt Rodgers, and to Capt Laird, the boarding officer, on duty at the Range Office, and with the request, to each, to keep the matter quiet.

A constant watch has been kept, at this port, for the "Amadis", but so far, she has not been sighted.

Any further developments, in this matter, coming to my attention, will be reported, promptly.



Sir:

Referring to the Department's telegram of the 12<sup>th</sup>, repeated to Port Tampa on the 14<sup>th</sup>, in regard to the filibustering expedition in which the yachts Lagonda and Amadis were alleged to be engaged, I beg to report that at the request of the collector of Customs at Fernandina dated the 13<sup>th</sup> I proceeded to that port on the following day but on arriving there I found that I could do but little, Special Inspector Anderson and the District Attorney having

already been there.

I desire in this connection to call to the attention of the Department what I consider an inexcusable delay on the part of the Collector in reporting this case and, in view of his acknowledged ignorance of how to act, in not seeking the aid and advice of the officers of the Government near him. Owing to his failure to do this he allowed two of the principals in the expedition to escape, thus shutting off about the only means of discovering against what country the expedition was directed. The Collector informs me that on Monday the 7<sup>th</sup> his suspicions were first aroused but it was not until Thursday that he made any move and then wired the Captain of

the Revenue cutter Bontwell at Savannah which vessel being under repairs could not respond. Friday) the Captain of the Lagonda went to the Collector ~~and~~ and reported that a number of suspicious boxes had been put on the yacht the night before and asked if any suspicion had been directed towards the yacht. The collector sent his Deputy on board with the captain but owing to a refusal to allow, on the part of the agent of the yacht, A. B. Borden, made no examination of the contents of the boxes. Sunday the captain of the yacht reported that arms had been thrown overboard from the vessel but it was only on Monday, after the arrival of Special Inspector Anderson that any search was made

and then 140 boxes of arms, ammunition and accoutrements were found in and seized at the warehouse of A. B. Borden.

The matter is now in the hands of the District Attorney for the Southern District of Florida. While in Fernandina I found that A. B. Borden, who appears conspicuously in the arrangement of the details of the expedition, was acquainted with José Martí, a well known Cuban revolutionist, and had entertained him at Fernandina no later than last October - and while I doubt that this was a full-fledged expedition against that island I think he was interested in it to the extent that he desired to show to the Cubans in this country who had contributed to the revolutionary fund that he

had collected that he was trying to do something.

I have directed the collector at Fernandina to make a full report to the Department and will not therefore enter into the details of his movements.

Sir:

As indicated in my telegram, of last night, to Department, the "Amadis" arrived at this port, at 7.30 yesterday evening; was taken charge of by the Collector, who placed her in the custody of Capt Rodgers, of the Revenue Cutter "Boutwell", with instructions to hold her, until further orders.

The yacht was searched, and nothing of a contraband nature found. She is commanded by Capt D. A. Weed,

Secty. 2,

of Rockland, Maine, who states she is owned by Mr G. H. Kimball, of Cleveland, Ohio; that she was chartered by N. D. Borden, but did not know for what purpose, or where she was to go, but supposed it was intended as a pleasure cruise. His orders, at Boston, being to run to Savannah, where he would be met by Borden.

We have kept a constant lookout, at the Hotels, for the Mess Mantel + Borden, but so far, they have not been found.

Capt. Weed, on arrival, found several telegrams awaiting him, from Mr Kimball, all of which he willingly handed over to the Collector. Among them was one dated Boston, Jan 15<sup>th</sup> stating "Charter forfeited, return immediately," & c. No letters, or
