DURING THE EVENING HOURS OF JULY 15, 1978, UNKNOWN INDIVIDUALS FIRED AT LEAST ONE SHOT AT THE TRUJILLO ALTO RESIDENCE OF FORMER PUERTO RICAN GOVERNOR, LUIS MUNOZ-MARIN, NO INJURIES WERE SUSTAINED.

POLICE OF PUERTO RICO (POPR) OFFICER ON THE SCENE (ALL FORMER GOVERNORS ARE AFFORDED PROTECTION BY POPR) ADVISED THE SHOT WAS FIRED FROM A SMALL, RED SEDAN, APPARENTLY

IT IS NOTED THAT ON JULY 17, 1978, MUNOZ REVEALED IN A PREPARED STATEMENT THAT HE WILL BECOME POLITICALLY ACTIVE AGAIN AND SPEAK THROUGHOUT THE ISLAND ADVOCATING HIS PARTIES PLATFORM. MUNOZ IS VERY INFLUENTIAL IN HIS PARTY.

SAN JUAN INDICES NEGATIVE REGARDING ANTI-IMPERIALIST ARMED FRONT. SAN JUAN NOTES POSSIBILITY THAT AFOREMENTIONED "ATTACK" MAY HAVE BEEN EFFORT BY PERSONS UNKNOWN TO PRECLUDE MUNOZ FROM RE-ENTERING ACTIVE POLITICS. PAGE THREE UNCLAS E F T O
