SUBSEQUENTLY, AN ANONYMOUS TELEPHONE CALL WAS RECEIVED BY A LOCAL RADIO STATION IN WHICH CALLER CLAIMED CREDIT FOR THE ATTACK IN THE NAME OF THE "ANTI-IMPERIALIST ARMED FRONT" AND WENT ON TO STATE THAT THIS ACTION WAS PART OF A LARGER "WAR PLAN".

ADMINISTRATIVE:

LUIS MUNOZ-MARIN IS A MEMBER OF THE LOCAL POLITICAL PARTY WHICH ADVOCATES MAINTAINING COMMONWEALTH STATUS AS OPPOSED TO STATEHOOD AND/OR INDEPENDENCE. IT IS NOTED THAT ON JULY 17, 1978, MUNOZ REVEALED IN A PREPARED STATEMENT THAT HE WILL BECOME POLITICALLY ACTIVE AGAIN AND SPEAK THROUGHOUT THE ISLAND ADVOCATING HIS PARTIES PLATFORM. MUNOZ IS VERY INFLUENTIAL IN HIS PARTY.

SAN JUAN INDICES NEGATIVE REGARDING ANTI-IMPERIALIST ARMED FRONT. SAN JUAN NOTES POSSIBILITY THAT AFOREMENTIONED "ATTACK" MAY HAVE BEEN EFFORT BY PERSONS UNKNOWN TO PRECLUDE MUNOZ FROM RE-ENTERING ACTIVE POLITICS.
